

20 **IT IS HEREBY ORDERED**, granting judgment in favor of Nuvell and against
21 Defendants as follows:

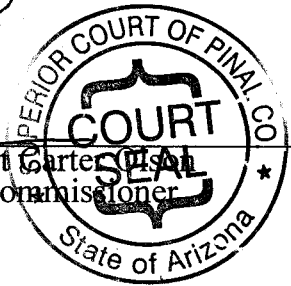
22 A. Awarding Judgment in favor of Nuvell and against Defendants in the
23 principal sum of \$14,658.46 (which includes recovery expenses, late fees, and interest
24 through October 20, 2007), plus interest continuing to accrue at the rate of 23.45% per
25 annum (\$7.74 per diem) on the principal balance of \$12,040.92 until paid in full;

26 B. Awarding Judgment in favor of Nuvell and against Defendants for reasonable
27 attorneys' fees in the sum of \$ 848⁰⁰, taxable costs in the sum of \$790.75,

1 together with interest on these sums accruing at the rate of 10% per annum, pursuant to
2 A.R.S. § 44-1201, from the date of the Judgment until paid in full and Post Judgment costs
3 and attorneys' fees as incurred.
