**A RESOLUTION OF THE BOARD OF SUPERVISORS OF PINAL COUNTY  
APPROVING LICENSING, IMPOUND AND SURRENDER FEES OF THE PINAL  
COUNTY ANIMAL CASER AND CONTROL FEE SCHEDULE**

**RECITALS:**

**WHEREAS** the Pinal County Board of Supervisors is empowered to establish fees for the administration of an Animal Care and Control department pursuant to A.R.S. § 11-1001 *et seq.*;

**WHEREAS** the Pinal County Board of Supervisors have adopted a fee schedule which has been published and available to the public on the Pinal County Animal Care and Control web site, and available for review by the public;

**WHEREAS** the Pinal County Animal Care and Control needs to update the fee schedule to reflect the costs associated with the administration and operations related to the licensing, impound and surrender of dogs, and cost of care for services.

**ENACTMENTS:**

**NOW, THEREFORE, BE IT RESOLVED** that the Pinal County Board of Supervisors hereby adopt the following fee schedule as the Pinal County Animal Care and Control Fee Schedule:






